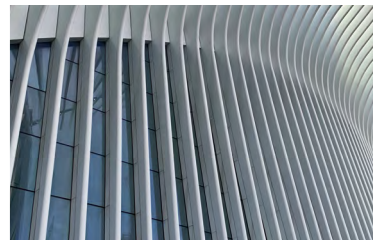
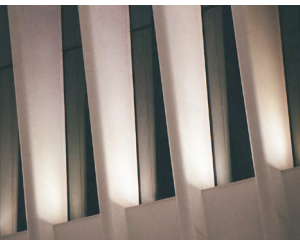

Attendees will be introduced to the fundamental concepts behind engineering, and the most commonly-used building materials. The concepts portion defines structural engineering, discusses building classifications and codes, and explains structural members, components, and loads. The concepts portion also covers design methods and methodologies, and common performance expectations and shortfalls.

Attendees will learn about the importance of foundations in controlling risk of building movement. Attendees will learn about geotechnical investigations and reports, often used in construction litigation, foundation optimization, and soil stabilization. The site work portion addresses site conditions, excavations, bracing, protecting adjacent structures, and creating a safe work environment for workers.

Attendees will learn about the composition, proportioning, and properties of concrete; the manner in which concrete is formed and reinforced; the most common uses of concrete in modern buildings, including pre-stressed, post-tension, and precast concrete; concrete placement, finishing and curing; and concrete durability problems.

### **Steel**

Attendees will learn about both the design and construction of structural steel, and how steel is typically used in the construction process, including the engineering, detailing, fabrication, and erection. ### **Roofing**

Attendees will learn about roofing systems in new construction and replacement of existing roofing systems, giving attorneys knowledge to evaluate these issues when negotiating roofing-related contracts and resolving roofing-related disputes.

Attendees will learn about the fundamental information for construction lawyers to know in handling a masonry case.

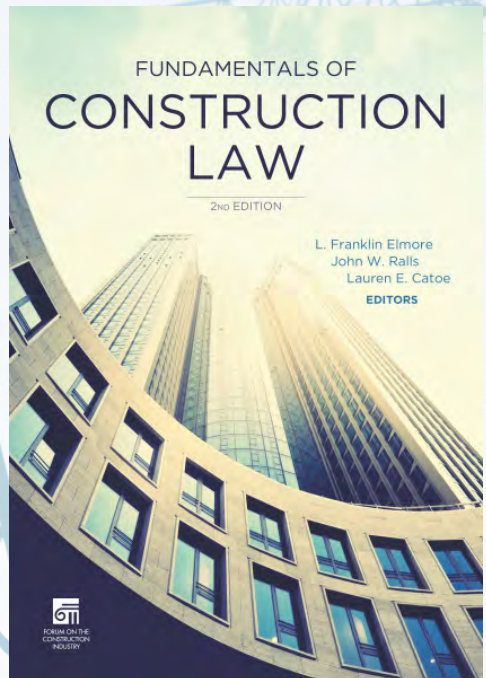
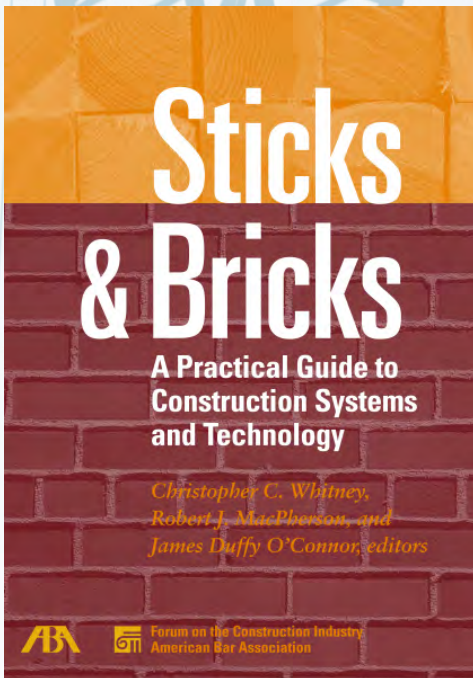
### 3:30 P.M. - 4:30 P.M. **Curtain Wall**

Attendees will learn about heating, ventilating, and air conditioning (HVAC) systems (aka mechanical systems), and electrical and plumbing systems. This session provides attendees with a general understanding of the plumbing systems used in common commercial buildings. The session addresses two main categories of electrical work: electrical systems over 120 volts; and electronic, or low voltage systems under 120 volts.
